1. OBJECTIVES OF THE ASSIGNMENT

The overall objective of the assignment is to provide Consultancy Services for the detailed master plan and design and construction supervision of Nairobi Waldorf School Karen Campus.

2. SCOPE OF WORK

The scope of the assignment will include;

Phase I: Master Plan and Design Stage

i. Detailed master plan and design of the Nairobi Waldorf School on the new site.

- ii. Preliminary & detailed building design and preparation of related drawings, including structural, electrical, and mechanical.
 - iii. Preparation of technical specifications.
 - iv. Preparation of detailed bill of quantities.
 - v. Application for county approvals.
 - vi. Preparation of tender documents for contractors.
- vii. Tendering document review, interview, and recommendation for appointment of a general contractor.

Phase II: Construction Stage

- i. Site handover to contractor and initiation of building works.
 - ii. Supervision of construction works.
 - iii. Periodic inspection of works to control quality, schedule & cost.
 - iv. Handover of tested, commissioned, and complete Project to the NWST board of Trustees.
 - iv. Provision of post-construction services during Defects Liability Period

3. QUALIFICATION REQUIREMENTS

- i. Interested consultants must provide the information required and meet the following minimum qualifications (mandatory) to be shortlisted:
 - a. Provide Company Profile of the firm, including names and addresses;
 - b. Provide statutory documents, namely
 - Certificate of registration
 - Tax compliance certificate
 - I-tax Pin Certificate
 - c. The Company must have been registered for five years from the date of submission of the EOI.
 - d. The Company should demonstrate the financial capability to carry out the works with a minimum average annual turnover of over Ksh 10 Million for the last three years. Provide Audited accounts for the last 3 (three) consecutive years (2018,2019,2020);
 - e. Provide Curriculum vitae of key personnel with over ten years relevant experience, registered by the relevant professional bodies in Kenya. Include an

experienced team leader, Quantity surveyor, civil engineer, structural engineer, etc. electrical engineer, mechanical engineer, and environmental expert.

- f. Demonstrated experience in school design., Provide evidence of one school design carried out; relevant experience in concept design, design development, and supervision of school construction by providing details of similar assignments giving the name and contact address of the Client, the value of the assignment, and period covered to undertake the assignment.
- g. The Company should demonstrate that they have resources to support the work, such as an equipped office and relevant equipment.
- h. Consultants may associate to enhance their qualifications. A firm submitting the EOI in a joint venture will be required to submit a duly signed and certified Joint Venture Agreement stating the responsibility of each partner in the Joint Venture and the name of authorized signatories through a power of attorney signed by each joint venture.

4. EVALUATION PROCESS

The evaluation process will be in two steps;

Step I: Eligibility requirements

A preliminary evaluation to assess the eligibility of the firms submitting the EOI shall be carried out.

The mandatory requirements are listed below. The evaluation at this stage will be on a "pass" or "fail" basis. A consulting firm must achieve a "pass" on all the criteria to proceed. Any consulting firm not achieving a 'pass' in any criterion will be disqualified and not be evaluated further.
